

**KSDCA Minutes**  
**January 28, 2018**  
**Salina, Kansas**

Allen H. called the meeting to order at 1:00 PM Sunday at the Belmont Boulevard Christian Church. He welcomed everyone that was there and thanked Sue D. for arranging for us to meet at the church. A moment of silence was held for Bill Gough, Kerry Wallace, family of Richard Verge, and Joan Smith.

The Minutes had previously been sent out by e-mail. Sheldon L. moved minutes be accepted as written, David M. second, motion passed.

Treasure's report: Mike T. gave the treasure's report stating that balance on May 1, 2017 there was \$3,502.11 in the Treasure. Deposits of \$32.21 were made and checks paid out was \$58.40 leaving a balance of \$3,475.92 on December 31, 2017. Three scholarships were paid at this meeting to Betty S., Sue D., and Jeanne S., who also gave a report on Roundalab. Checks were also written for ribbons to the State Square Dance Convention. Dale S. moved to accept the treasurer's report, David M. second, motion passed.

Tom H., Caller Coordinator, reported that ticket sales are going well. At the KSDA dance, that afternoon, they will be selling tickets for the state convention. They are trying out a new method of selling tickets by credit cards just at the dance. There is a new contract that was negotiated by Allen H. and George and Nancy Sloop for the Tony's Pizza Event Center. It does not include using the Arena. The usage will be for the three Heritage Halls and 2 rooms upstairs on Saturday morning for the meetings and Sewing Clinic. The Saturday evening beginning program will be held in Heritage South Hall. Allen H. reported that the contract will be for 5 years, running through 2022, and will save about a third of the price that we are now paying for the center

Allen H. reported on the program for the State Square Dance Convention. Allen passed out a tentative schedule for the week-end. He is also planning on using the featured caller and cuer more. Kevin D. proposed the possibility of having the featured cuer cue upper level rounds in the Round Dance Hall sometime during the evening program on Saturday night. The feature cuer would begin and end in Heritage South and would occasionally do upper level rounds in the Round Dance Hall coordinating with a local cuer in Heritage South during that time. The idea came from Colorado State Square Dance Convention.

Motel for the convention will be the Country Inn and Suits. The price will be in the \$70.00's. Camping registration needs to be in soon in order to hold you spot.

Sound Chairman will be David M. during the convention. Sounding the halls will be: Heritage South Dana S. for \$200.00, Heritage NW David M. for \$75.00, and Heritage NE Stash T. for \$75.00. Peggy A. moved that we accept the sound bids, Terry L. second, and motion passed.

Sue moved that we pay half of the admission for youth for the 2018 State Convention. David M. second and motion passed.

Nominating report ask anyone interested in running for office to contact Sue D.

David M. moved that we continue giving the Honorary Members free tickets to the State Convention, Sue D. second, motion passed. They may pick them up at the door when they come to the convention.

Jeanne and Warren Shane have agreed to be Caller Coordinator for 2019.
