KSDCA shall annually award up to one (1) scholarships of \$200.00 to assist its members with the expenses of attending any training that improves an aspect of calling/cueing. If the training is not a CALLERLAB /ROUNDALAB /CONTRALAB / NTA/CLOG approved, a written description of the training must accompany the application and be approved by the Executive Committee prior to the drawing.

DRAWING:

- 1) Selection of scholarship winners shall be by impartial drawing of names of those who have applied. The drawing shall be conducted at the January meeting.
- 2) Scholarship applications must be submitted to the Secretary **before the start** of the January Annual Meeting. Obtaining and submitting the application is the responsibility of each individual caller.

ELIGIBILITY:

Any active or associate member of the Association in good standing who has been an active or associate member for a minimum of one (1) year prior to the date of the drawing. See the Constitution and Standing Rules for more requirements.

RESPONSIBILITIES OF SELECTED APPLICANTS:

- 1) It is understood that the recipient of a scholarship award will present a written report to the KSDCA Secretary of the experiences of the school or activity along with proof of a minimum of \$200 in expenses with-in 60 days following the completion of the activity or school.
- 2) The selected applicant is expected to present the certificate of attendance, which is part of this form, to the Director of the School, or his agent, and to return the completed form to the Secretary of the Association.
- 3) The scholarship must be used within 24 months of the drawing, and a scholarship winner cannot reapply for three (3) years from the date of the winning drawing.

RESPONSIBILITIES OF THE KANSAS CALLERS ASSOCIATION:

- 1) The Association Secretary shall return the application form to the winners at least 15 days prior to the announced starting date of the school. The Secretary shall receive all completed certificates of attendance and direct the Association Treasurer to make proper payment to the member.
- 2) The Secretary will notify all members of the Association of the results of the drawing within 20 days after each drawing.
